THE PRESIDENT OF THE PRE-TRIAL DIVISION of the International Criminal Court hereby issues this decision amending the roster within the meaning of regulation 46(3) of the Regulations of the Court (respectively, the ‘Roster’ and the ‘Regulations’) pursuant to the authority vested in him to oversee the administration of the Pre-Trial Division as set forth in regulation 14 of the Regulations.

1. On 1 March 2023, the then President of the Pre-Trial Division issued the ‘Decision amending the roster within the meaning of regulation 46(3) of the Regulations of the Court’ (ICC-ROC46(3)-9, the ‘1 March 2023 Decision’).

2. On 21 March 2025, Judge Sergio Gerardo Ugalde Godínez assumed the function of President of the Pre-Trial Division.

3. The President of the Pre-Trial Division notes that the Roster has not been amended following the expiry of the Roster adopted by means of the 1 March 2023. Accordingly, as set out in the annex to the present decision, the President of the Pre-Trial Division hereby amends the Roster with retroactive effect from the date of the expiry of the Roster adopted by means of the 1 March 2023 Decision.

4. While the present decision shall be made available publicly, the roster itself shall not be communicated to the Registry, the Prosecution and the general public.

AMENDS the roster within the meaning of regulation 46(3) of the Regulations in accordance with the annex to the present decision.
