PRE-TRIAL CHAMBER I (the ‘Chamber’) of the International Criminal Court (the ‘Court’) issues this order to the Registry to reclassify a warrant of arrest that at present is classified as under seal.

1. On 10 July 2025, the Chamber issued a warrant of arrest for Khaled Mohamed Ali El Hishri (‘Mr El Hishri’ and the ‘Warrant of Arrest’), with an ‘under seal, *ex parte*, only available to the Prosecution and the Registry’ classification.¹
2. On 16 July 2025, following a request for the arrest and surrender of Mr El Hishri from the Court to the Federal Republic of Germany, the suspect was arrested in Germany.
3. Besides the German authorities, Mr El Hishri also received the Warrant of Arrest. As it is now public information that Mr El Hishri was arrested pursuant the Warrant of Arrest, the Chamber considers it appropriate to unseal this document.

FOR THESE REASONS, THE CHAMBER HEREBY

INSTRUCTS the Registry to reclassify filing number ICC-01/11-188-US-Exp as public.
