PRE-TRIAL CHAMBER I (the ‘Chamber’) of the International Criminal Court (the ‘Court’), issues this order scheduling a hearing for the first appearance of Mr Khaled Mohamed Ali El Hishri (‘Mr El Hishri’).

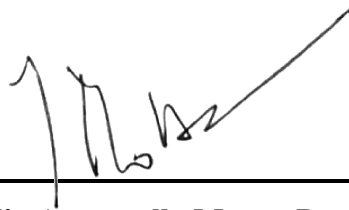
1. On 10 July 2025, the Chamber issued a warrant of arrest for Mr El Hishri (the ‘Arrest Warrant’) for alleged crimes against humanity and war crimes in the situation in the Libyan Arab Jamahiriya.¹
2. On 1 December 2025, Mr El Hishri was surrendered to the Court and arrived at the Court’s Detention Centre that same day.
3. According to article 60(1) of the Rome Statute and rule 121(1) of the Rules of Procedure and Evidence, a person subject to a warrant of arrest under article 58 of the Statute ‘shall appear before the Pre-Trial Chamber’ and be informed of (i) the crimes he is alleged to have committed; (ii) his rights under the Statute; and (iii) the date for a hearing to confirm or to decline to confirm the charges.
4. A first appearance should take place as soon as practically feasible after a suspect has been taken into the custody of the Court. The Chamber therefore considers it appropriate for the first appearance of Mr El Hishri to take place on 3 December 2025 at 13:30. This public hearing will be broadcasted with a thirty-minute delay in order to protect any potential sensitive information, in accordance with regulation 21(2) of the Regulations of the Court.

¹ Warrant of Arrest for Mr Khaled Mohamed Ali El Hishri, ICC-01/11-188-US-Exp. The Arrest Warrant was unsealed and made available to the public pursuant to a Chamber’s reclassification order dated 31 July 2025 (ICC-01/11-188).

FOR THESE REASONS, THE CHAMBER HEREBY

CONVENES the hearing for the first appearance of Mr El Hishri on Wednesday, 3 December 2025, at 13:30 hours.
