I. INTRODUCTION

1. The Registry hereby submits the present document and its annex consisting of the E-court Protocol, pursuant to the “*Order on the E-Court Protocol*” (“Order”), issued on 3 December 2025 by Pre-Trial Chamber I (“Chamber”).¹

II. PROCEDURAL HISTORY

2. On 2 December 2025, the Chamber issued its “*Scheduling order for the first appearance of Mr Khaled Mohamed Ali El Hishri*”.²
3. On 3 December 2025, the Chamber held the first appearance hearing of Mr El Hishri, and scheduled the confirmation of charges hearing to commence on 19 May 2026.³
4. On the same day, the Chamber issued its Order, in which it instructed the Registry to file the latest version of the Unified Technical Protocol for the provision of evidence, witnesses and victims information in electronic form (“E-court Protocol”) in the present case record.⁴

III. APPLICABLE LAW

5. For the purpose of the present submission, the Registry has considered *inter alia* regulation 26(4) of the Regulations of the Court and regulation 10(1), (4) and (5) of the Regulations of the Registry.

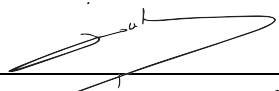
