I. INTRODUCTION

1. The Registry hereby transmits to the Appeals Chamber (“Chamber”), the *“Joint Victims’ Request to submit Observations on Israel’s “Request to Disqualify the Prosecutor and for Ancillary Remedies””,* (“Request”), received from Raji Sourani, Chantal Meloni, Triestino Mariniello, Jeanne Sulzer, Clémence Witt, Rodney Dixon KC (“Submitters”), on 08 December 2025.

II. PROCEDURAL HISTORY

2. On 08 December 2025, the Registry received an e-mail from the Submitters, with a document attached consisting of the Request.¹
3. On the same day, the Registry consulted the Chamber to seek guidance on whether and how to place the Request on the case record.²
4. The Chamber subsequently instructed the Registry to submit the Request *via* a Registry transmission filing (“Instruction”).³

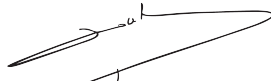
