I. Introduction

1. The Registry hereby transmits to Pre-Trial Chamber II (“Chamber”), Tajikistan’s further submissions pursuant to Pre-Trial Chamber II’s Decision dated 5 November 2025,¹ (“Further Submissions”), received on 22 December 2025 from the Republic of Tajikistan (“Tajikistan”).²

II. Procedural History

2. On 5 November 2025, the Chamber issued its “Decision inviting Tajikistan to provide any further submissions on its failure to arrest and surrender Vladimir Vladimirovich Putin” (“Decision”). The Chamber invited Tajikistan, if it so wished, to provide submissions by Wednesday, 3 December 2025.
3. On 4 December 2025, Tajikistan confirmed that it wished to make further submissions, and to that end, requested that the Chamber grant an extension of the deadline.³
4. On 8 December 2025, the Chamber granted Tajikistan an extension of time until 19 December 2025.⁴
5. On 19 December 2025, Tajikistan informed the Registry that additional information was expected to be provided on 20 December 2025.⁵

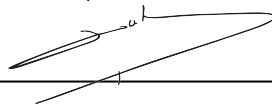
