PRE-TRIAL CHAMBER I (the ‘Chamber’) of the International Criminal Court (the ‘Court’), issues this order scheduling a first status conference in the case against Mr Khaled Mohamed Ali El Hishri (‘Mr El Hishri’).

1. On 3 December 2025, during Mr El Hishri’s first appearance, the Chamber decided to conduct a number of status conferences to ensure that the exchange of information *inter partes* is carried out seamlessly and adequately. The Chamber further informed that the first such status conference would take place on either 28 or 29 January 2026.¹

2. The Chamber hereby convenes this status conference on Wednesday, 28 January 2026, starting at 14:00 hours, and confirms that a detailed agenda will be circulated via email after receipt of the parties’ written submissions due on 15 January 2026.²

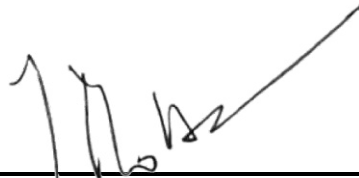
