I. INTRODUCTION

1. On 23 April 2026, Pre-Trial Chamber I (“Chamber”) issued its “Public redacted version of ‘Decision on the confirmation of charges against Mr Rodrigo Roa Duterte’, 23 April 2026” (“Decision”) in which it ordered the Registrar to transmit the Decision and the record of the proceedings to the Presidency.¹

II. LEVEL OF CLASSIFICATION

2. Pursuant to regulation 23*bis*(1) of the Regulations of the Court, Annexes 1 to 3 to the present transmission are classified as secret and confidential, *ex parte* only available to the Presidency as they refer to secret, under seal, confidential and confidential *ex parte* submissions that should only be accessible to the Presidency at this stage of the proceedings.

III. APPLICABLE LAW

3. The present transmission is submitted pursuant to rule 129 of the Rules of Procedure and Evidence, regulation 23*bis*(1) of the Regulations of the Court and in compliance with the Decision.
