I. Introduction

1. The Registry hereby informs Trial Chamber III ("Chamber") that Mr Rodrigo Roa Duterte ("Mr Duterte") requested to be represented by Mr Peter Haynes KC ("Mr Haynes KC") in the proceedings before the International Criminal Court ('the Court'). The appointment has been confirmed by the Registry on 15 May 2026, following Counsel's acceptance of the appointment.

II. Procedural history

2. On 8 May 2026, Mr Nicholas Kaufman ("Mr Kaufman"), pursuant to regulation 78(1) of the Regulations of the Court, requested the Chamber's "leave to withdraw as Counsel for Mr Rodrigo Roa Duterte in the case of *the Prosecutor v. Rodrigo Roa Duterte* (ICC-01/21-01/25)" ("Request").¹ In his Request, Mr Kaufman indicated that "the Defence team visited Mr Duterte and documented both Mr Duterte's release of Counsel from his representation and his desire to hire replacement Counsel – Mr Peter Haynes."² Mr Kaufman further stressed that "Counsel has spoken to Mr Haynes who has indeed confirmed that he is ready willing and able to assume immediate representation and that his terms of engagement have been agreed."³
3. On 11 May 2026, the Chamber granted the Request.⁴

III. Classification

4. The present submission and its Annexes I and II are classified as public, whereas Annex III hereto is classified as confidential, in accordance with regulation 23*bis* of the Regulations of the Court ("RoC") as it contains private contact details of Mr Haynes KC.

IV. Applicable Law

5. The following provisions are of particular relevance to the present submission: article 67(1)(d) of the Rome Statute, rules 21 and 22 of the Rules of Procedure and Evidence, regulations 23*bis*, 67, 69 of the RoC, regulation123 of the Regulations of the Registry and articles 5 and 8 of the Code of Professional Conduct for counsel ("Code").

V. Submissions

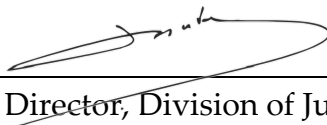
6. On 13 May 2026, Mr Duterte signed the appointment of counsel form whereby he confirms his appointment of Mr Haynes KC as his Counsel in the proceedings before the Court.⁵
7. On the same day, 13 May 2026, Mr Haynes accepted the mandate, as required by article 11 of the Code.⁶
8. On 15 May 2026 , the Registry officially formalized the appointment of Mr Haynes KC as Counsel for Mr Duterte.⁷

9. Mr Haynes KC has previously executed the solemn undertakings as required under Article 5 of the Code, which remain valid throughout the proceedings before the Court.⁸
10. Mr Haynes KC confirmed to the Registry that he does not have any impediment to the representation of Mr Duterte in the proceedings before the Court or a conflict of interest in accordance with articles 12 and 16 of the Code.
