The Appeals Chamber of the International Criminal Court,

In the appeals of the Deputy Prosecutor, Mr Alfred Yekatom and Mr Patrice-Édouard Ngaïssona against the decision of Trial Chamber V entitled “Judgment” of 24 July 2025 (ICC-01/14-01/18-2784-Red),

Having before it the “Yekatom Defence Request for Reclassification” of 15 May 2026 (ICC-01/14-01/18-2918),

Pursuant to regulation 23*bis*(3) of the Regulations of the Court,

Issues the following

ORDER

The Registrar is directed to reclassify document ICC-01/14-01/18-2902-Conf as public.

REASONS

1. Regulation 23*bis*(3) of the Regulations of the Court provides that a Chamber may reclassify a document when the “basis for the classification no longer exists”.
2. Noting the submission of the Defence for Mr Yekatom that the information contained in document ICC-01/14-01/18-2902-Conf “no longer warrants redaction”,¹ the Appeals Chamber directs the Registrar to reclassify same as public.
