I. INTRODUCTION

1. The Registry hereby submits as annexes to this filing, the public and confidential presentations used during the confirmation of charges hearings (“Confirmation Hearings”), held from 19 to 21 May 2026, in the case of *The Prosecutor v. Khaled Mohamed Ali El Hishri* (“Case”).

II. PROCEDURAL HISTORY

2. During the Confirmation Hearings, the Office of the Prosecutor and the Defence for Mr El Hishri (“together, “Parties”) relied on presentations in support of their oral submissions.¹

5. For the purpose of the present submission, the Registry has considered *inter alia* regulations 21, 24, 26 and 29(1) of the RoR.

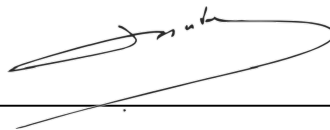
