I. INTRODUCTION

1. On 16 July 2026, Pre-Trial Chamber I (“Chamber”) issued its “Decision on the confirmation of charges against Mr Khaled Mohamed Ali El Hishri”,¹ (“Decision”) in which it ordered the Registrar to transmit the Decision and the record of the proceedings to the Presidency.

II. LEVEL OF CLASSIFICATION

2. Pursuant to regulation 23*bis*(1) of the Regulations of the Court, Annexes 1 to 3 to the present transmission are classified as under seal and confidential, *ex parte* only available to the Presidency, as they refer to under seal, confidential and confidential *ex parte* filings that should be accessible only to the Presidency at this stage of the proceedings.
