**TRIAL CHAMBER VI** of the International Criminal Court, in the case of *The Prosecutor v. Mahamat Said Abdel Kani*, having regard to article 74 of the Rome Statute (the ‘Statute’), and rules 142 and 144 of the Rules of Procedure and Evidence (the ‘Rules’) issues this ‘Scheduling Order for Delivery of the Trial Judgment’.

1. On 26 September 2022, the trial of Mr Said opened.
2. On 15 November 2024, the Office of the Prosecutor formally closed its case.<sup>1</sup>
3. On 17 March 2025, the Chamber heard the first Defence witness and on 2 September 2025, the Defence formally closed its case.<sup>2</sup>
4. On 9 September 2025, the Chamber declared the presentation of evidence closed.<sup>3</sup>
5. From 25 to 26 November 2025, the Chamber heard the closing statements of the parties and participants and subsequently retired to deliberate on its judgment pursuant to article 74 of the Statute.
6. The Chamber hereby announces that its judgment pursuant to article 74 of the Statute will be delivered in a public hearing on 23 September 2026 at 11:00.

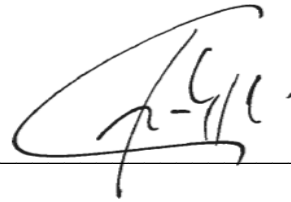
