I. INTRODUCTION

1. The Registry hereby submits its report on the implementation of the Trial Chamber III's ("Chamber") "*Decision on the Prosecution's request for materials in the custody of the Registry*", issued on 28 May 2026,¹ and its subsequent "*Decision on the Prosecution's second request for materials in the custody of the Registry*", issued on 22 June 2026.²

II. PROCEDURAL HISTORY

2. On 1 May 2026, the Office of the Prosecutor ("Prosecution") submitted its "Request for materials in the custody of the Registry" ("First Request").³
3. On 7 May 2026, the Chamber, by way of e-mail, ordered the Registry and the Defence for Mr Duterte ("Defence") to submit any observations no later than 18 May 2026.⁴
4. On 18 May 2026, the Registry submitted its "observations on the Prosecution's request for materials in the custody of the Registry",⁵ and the Defence submitted its "Response to Prosecution's request for materials in the custody of the Registry".⁶

5. On 28 May 2026, the Chamber issued its “Decision on the Prosecution’s request for materials in the custody of the Registry”, in which the Chamber authorised the First Request (“First Decision”).⁷
6. On 9 June 2026, the Prosecution submitted its “second request for materials in the custody of the Registry” (“Second Request”).⁸
7. On the same day, the Chamber, by way of e-mail, ordered the Registry and the Defence to submit any observations no later than 16 June 2026.⁹
8. On 16 June 2026, the Registry submitted its “observations on the “Prosecution’s second request for materials in the custody of the Registry” (ICC-01/21-01/25-460-Conf-Exp)”,¹⁰ and the Defence submitted its “Response to Prosecution’s Second Request for Materials in the Custody of the Registry”.¹¹
9. On 22 June 2026, the Chamber issue its “Decision on the Prosecution’s second request for materials in the custody of the Registry” in which it partially granted the Second Request and ordered the Registry to transmit to the Prosecution the materials by 24 June 2026 (“Second Decision”).¹²

10. 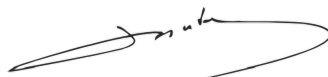
IV. SUBMISSIONS

11. The Registry informs the Chamber that, on 1 June 2026, it transferred custody and possession of the materials referred to in the First Decision to the Prosecution.

12. On 24 June 2026, the Registry transferred custody and possession of the materials referred to in the Second Decision to the Prosecution.

13. On 29 July 2026, the Prosecution transferred custody and possession of the materials referred to in the First and Second Decisions to the Registry.

14. The annexes to the present report contain the *procès verbal* describing the chain of custody of the relevant items.
