I. Introduction

1. On 9 December 2021, Pre-Trial Chamber II issued its “Decision on the confirmation of charges against Mahamat Said Abdel Kani” (“Decision”)¹ in which it *inter alia* ordered the Registrar to transmit the Decision on the confirmation of charges and the record of the proceedings to the Presidency.
2. On 10 December 2021, the Registry transmitted the record of the proceedings, including the Decision on the confirmation of charges against Mahamat Said Abdel Kani to the Presidency.²
3. On 14 December 2021, the Presidency issued its “Decision constituting Trial Chamber VI and referring to it the case of *The Prosecutor v. Mahamat Said Abdel Kani*”³ in which it ordered the Registrar to transmit the full record of the proceedings to Trial Chamber VI (“Chamber”), including the Decision Confirming the Charges, and to notify the present decision to the relevant parties and participants in the case.
4. On 15 December 2021, the Judges of the Chamber elected Judge Miatta Maria Samba as Presiding Judge and Single Judge for the preparation of the trial.⁴

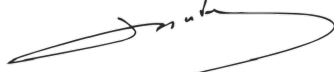
