The Registrar of the International Criminal Court (the "Court"),

NOTING the Decision on the Prosecutor's Urgent Application dated 26 September 2005¹, whereby Pre-Trial Chamber II (the "Chamber") on 27 September 2005 requested the Registrar to transmit to the Republic of Sudan the requests for arrest and surrender of Joseph Kony, Vincent Otti, Okot Odhiambo, Raska Lukwiya and Dominic Ongwen;

NOTING the requests for arrest and surrender issued by the Chamber on 27 September 2005² (the "Requests"), directing the Registrar, "in transmitting th[e] Request[s], to attach to [them...] a copy of the Warrant[s] and [their] annexes, in particular the relevant provisions of the Statute and the Rules concerning the rights of a person whose arrest is sought, as well as their translation in a language [the sought persons] fully understand[...] and speak[...]";

NOTING the Requests whereby the Registrar is to "consult the Prosecutor with regard to any documents, statements or information which may need to be attached to th[e] Request[s] in order to meet the requirements for the surrender process in the Requested State, as appropriate, pursuant to article 91, paragraph 2 (c), of the Statute"³;

NOTING that, the Republic of Sudan not being a State Party, the transmission is to be done through the diplomatic channel, namely the Embassy of the Republic of Sudan to the Kingdom of The Netherlands;

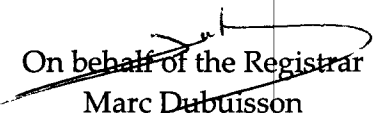
