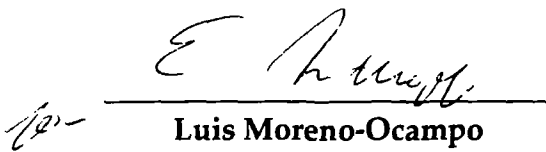

Background

1. On 28 August 2006, the Single Judge rendered the “Final Decision on the E-Court Protocol for the Provision of Evidence, Material and Witness Information in Electronic Version for their Presentation during the Confirmation Hearing”¹ (28 August 2006 Decision). Following the Prosecution’s 31 August 2006 “Request for Extension of Time, Clarification and Provision of Information”², the Single Judge on 1 September 2006 issued the “Decision on the Prosecution Request for Extension of Time, Clarification and Provision of Information”³ (1 September 2006 Decision).

Information

2. On 7 September 2006, the Prosecution, in compliance with the 28 August 2006 and the 1 September 2006 Decisions, provided the Registry with a CD containing all information as requested to be provided by the Prosecution by 7 September 2006.
3. At the request of Counsel for the Defence of 7 September 2006, the next disclosure meeting with the Defence has been postponed from Friday, 8 September 2006 to Monday, 11 September 2006. Accordingly, the Prosecution will provide a CD containing the related information for the Defence at the occasion of the 11 September 2006 disclosure meeting.
