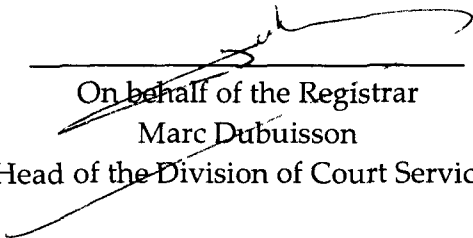
NOTING that during the Hearing, the Chamber decided that the material submitted was to be registered in the record of the proceedings¹;

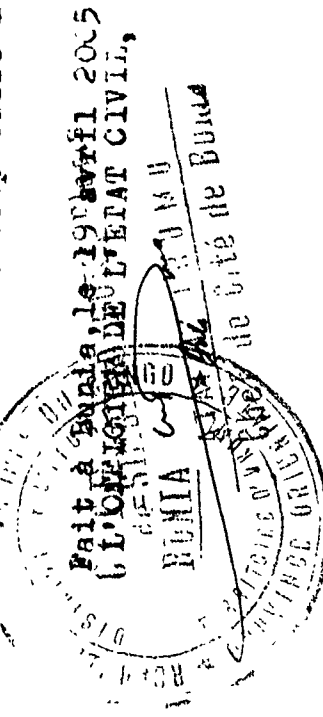

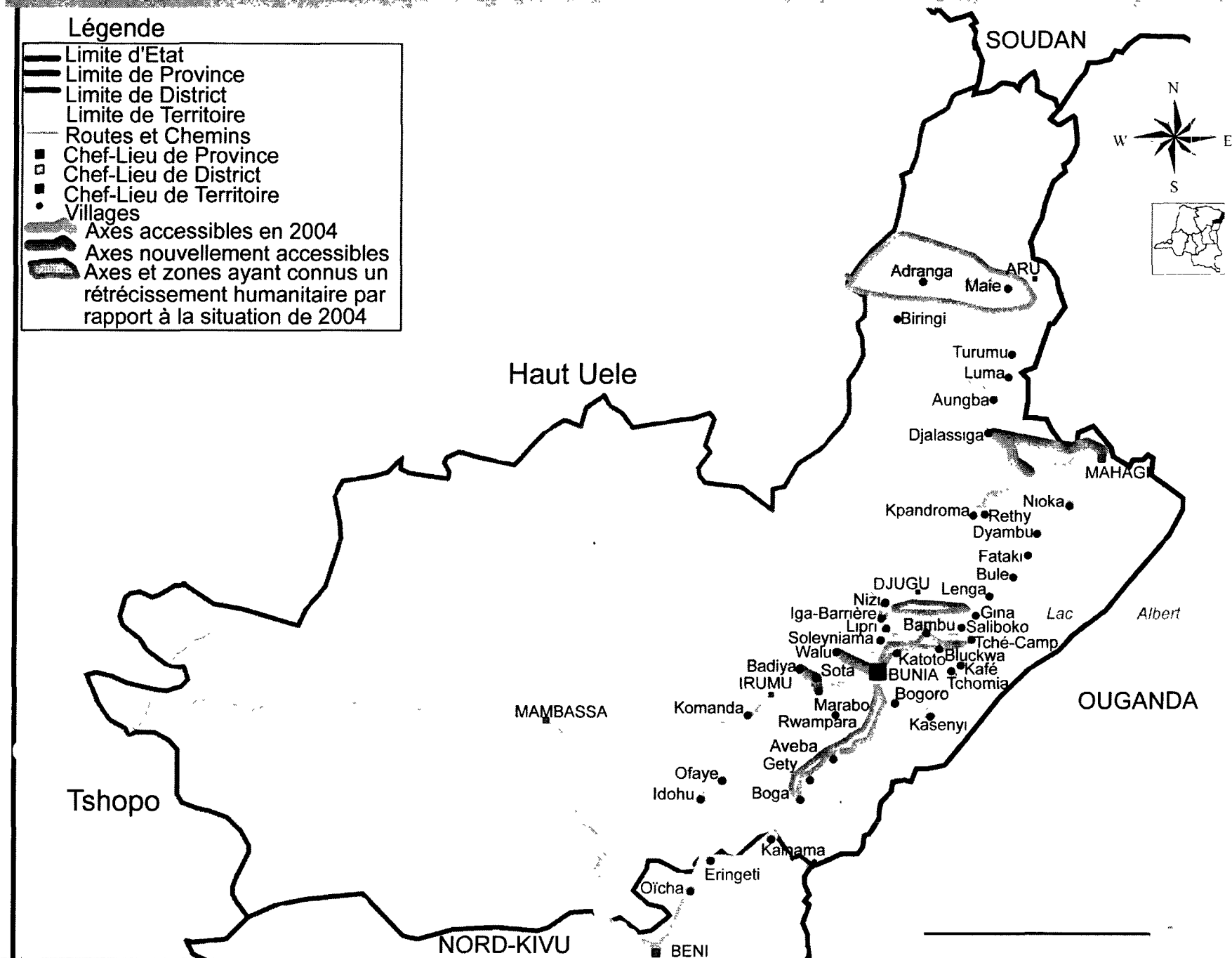
