Noting the order of the Presidency of 9 May 2007⁵, pursuant to which the Registrar informed the Appeals Chamber and Pre-Trial Chamber I of the First Application before the Presidency, on the grounds that the application related to proceedings before the abovementioned Chambers;

Noting that the First Application refers to an annex, Annex E, which is not currently before the Presidency⁶;

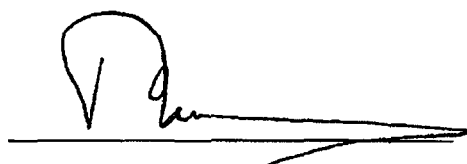
