Decision on the Designation of a Single Judge

PRE-TRIAL CHAMBER I of the International Criminal Court (the “Court”);

NOTING the “Decision Assigning the Situation in Darfur, Sudan to Pre-Trial Chamber I” issued by the Presidency on the 21 April 2005¹;

NOTING article 39, paragraph 2 (b) (iii) of the Rome Statute (“the Statute”), pursuant to which the functions of the Pre-Trial Chamber shall be carried out either by three judges of the Pre-Trial Division or by a single judge in accordance with the Statute and the Rules of Procedure and Evidence;

NOTING article 57, paragraph 2 (b) of the Statute, pursuant to which a single judge of the Pre-Trial Chamber may exercise the functions provided for in this Statute, unless otherwise provided for in the Rules of Procedure and Evidence or by a majority of the Pre-Trial Chamber;

NOTING rule 7, sub-rule 1 of the Rules of Procedure and Evidence and regulation 47, sub-regulation 1 of the Regulations of the Court, pursuant to which the designation of a single judge shall be based on criteria agreed upon by the Pre-Trial Chamber, including seniority of age and criminal trial experience;

CONSIDERING that at this stage of the proceedings concerning the Situation in Darfur, Sudan and any related case, the designation of a single judge will ensure the proper and efficient functioning of the Chamber;

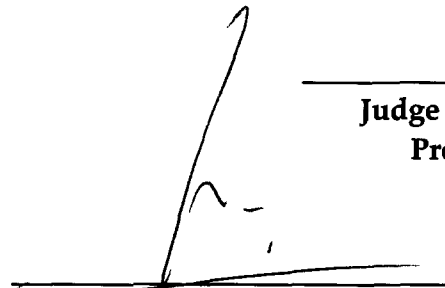

FOR THESE REASONS,

DECIDES to designate Judge Akua Kuenyehia as single judge of Pre-Trial Chamber I for the Situation in Darfur, Sudan and any related case from 10 May 2007 until otherwise decided by the Chamber;

DECIDES that, subject to article 57, paragraph 2 (a) of the Statute, the functions of Pre-Trial Chamber I concerning the Situation in Darfur, Sudan and any related case shall be carried out by the single judge from 10 May 2007 until otherwise decided by the Chamber.
