Pursuant to the Single Judge's "Corrigendum to the Decision Establishing Time Limits for Decisions on Protective Measures and Requests for Redactions"¹ and "Decision on the Request for Variation of Time Limit and on Matters concerning the Status Conference of 21 January 2008"², the Office of the Prosecutor ("Prosecution") respectfully submits an application for redactions to the documents that it intends to rely upon at the confirmation hearing ("Public Application"). The proposed redactions are requested pursuant to Rules 81(2) and (4) of the Rules of Procedure and Evidence, and further to the Single Judge's prior decisions on redactions to witness statements and related materials.³

Request for Receipt of Annexes as Confidential, *Ex Parte*, Prosecutor Only

The Prosecution appends to the Public Application an annex titled "Prosecution's Application Pursuant to Rule 81(2) and Rule 81(4) for Redactions to Documents to Be Relied Upon at the Confirmation Hearing" ("Confidential Application") as Annex 1. The documents for which redactions are proposed are annexed to the Confidential Application. The Prosecution respectfully requests that the Confidential Application and Annexes be received by the Single Judge as "Confidential, *Ex Parte*, Prosecutor Only" since they depict information for which redactions are sought and communication of such information would defeat the purpose for which the redactions are requested.

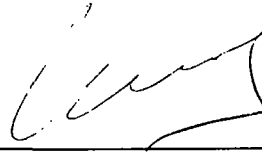
Request
