NOTING the *“Warrant of Arrest for Germain Katanga”*, issued by Pre-Trial Chamber I (“the Chamber”) on 2 July 2007¹ (“the Warrant of Arrest”);

NOTING the *“Order on the execution of the warrant of arrest for Germain Katanga”* issued by the Chamber on 2 July 2007² (“the Order”);

NOTING the *“Request to the Democratic Republic of the Congo for the arrest and surrender of Germain Katanga”* (“the Request”) issued by the Registrar on 6 July 2007;³

NOTING the *“Second informative report of the Registrar on the execution of the Request for the arrest and surrender of Germain Katanga”* (the “Report”) issued on 5 October 2007;⁴

NOTING the Single Judge’s *“Decision to unseal and reclassify certain documents in the record of the case against Germain Katanga”* (“the Decision”) dated 20 February 2008;⁵

NOTING regulations 23 bis and 24 bis of the Regulations of the Court;

CONSIDERING that, at the time of the issuance of the Report, the warrant of arrest against Germain Katanga was still underseal;

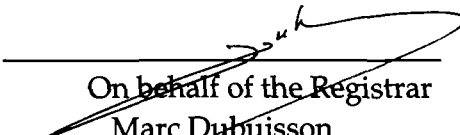
