NOTING the “*Decision Concerning Pre-Trial Detention of Germain Katanga*” (“the Decision”) issued by the Chamber on 21 February 2008⁷;

NOTING article 58, 60 and 87 of the *Rome Statute*, rules 118 and 119 of the *Rules of Procedure and Evidence* (“the Rules”) and regulations 34 and 51 of the *Regulations of the Court* (“the Regulations”);

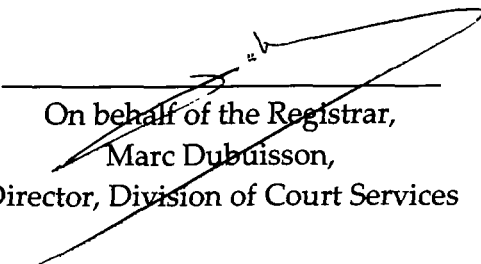
