NOTING the “Order Concerning Notification of Decision of 14 February 2008”¹ requesting the Registry to file by Friday 22 February 2008 at 16:00 hours in the record of the case *The Prosecutor v. Mathieu Ngudjolo Chui*: (i) information on how and when the Defence was notified of the Decision; and (ii) any record in his possession relating to such notification ;

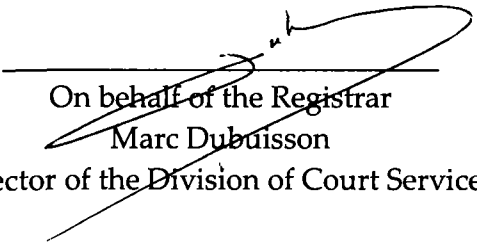
