NOTING the “Decision Convening a Hearing on 18 February 2008”¹ and the *ex parte* hearing held on 18 February 2008 with the Prosecution and the representatives of the Registry;

NOTING the Single Judge’s “Decision to unseal and reclassify certain documents in the record of the case against Mathieu Ngudjolo Chui”²;

NOTING Rule 18(a) of the Rules of Procedure and Evidence and Regulations 23 *bis* of the Regulations of the Court;

CONSIDERING that the Single Judge decided to unseal document ICC-01/04-02/07-4-US-Exp and that this document shall be reclassified as confidential and “*ex parte*, Prosecution only”³;

CONSIDERING that the Single Judge further decided that the Registrar shall file by Monday 25 February 2008 a public note explaining the general nature of document ICC-01/04-02/07-4-US-Exp⁴;

CONSIDERING that on 27 July 2007, the Registrar filed a document registered under seal, *ex parte* available to the Prosecution only and that this document was registered under the case number ICC-01/04-02/07-4-US-Exp;

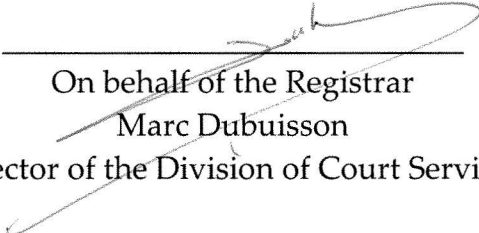
