NOTING the “Decision concerning the Notification of a decision to Mathieu Ngudjolo Chui” dated 18 March 2008¹ requesting the Registry to file by Wednesday 19 March 2008 at 16:00 hours in the record of the case *The Prosecutor v. Germain Katanga and Mathieu Ngudjolo Chui*: (i) information on how and when the Defence for Mathieu Ngudjolo Chui was notified of the Decision on Evidence and Information; and (ii) any record in his possession relating to such notification;

NOTING Regulation 31 of the Regulations of the Court;

CONSIDERING that it had been decided that in order to expedite the communication of the case file to the Duty Counsel, the copy would be provided to the Chief of the Defence Support Section to prompt communication over the week-end;

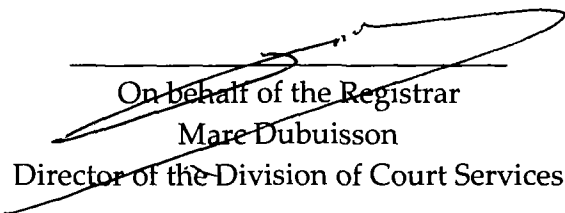
