NOTING the warrant of arrest for Mathieu Ngudjolo Chui filed by Pre-Trial Chamber I ("the Chamber") on 6 July 2007¹;

NOTING the "*Decision on the evidence and information provided by the Prosecution for the issuance of an arrest warrant against Mathieu Ngudjolo Chui*" filed on 6 July 2007²;

NOTING the "*Demande de mise en liberté provisoire*" ("the Application for Interim Release") issued on 13 February 2008³;

NOTING the "*Decision inviting Observations on the Defence's Application for Interim Release*" ("the Decision") issued on 14 February 2008⁴;

NOTING article 60 and 87 of the *Rome Statute*, rules 118 and 119 of the *Rules of Procedure and Evidence* ("the Rules") and regulations 34 and 51 of the *Regulations of the Court* ("the Regulations");

CONSIDERING that the Chamber invited the relevant authorities of Belgium, France, the United Kingdom and the Netherlands to submit observations by no later than 29 February 2008 on 1) the Application for Interim Release and 2) the conditions that would have to be met in order for the State to accept Mathieu Ngudjolo Chui's release on to its territory⁵;

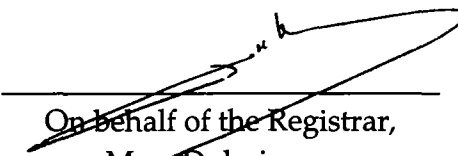
