NOTING the "*Demande de la Défense de Mathieu Ngudjolo afin d'autoriser le Bureau du Conseil Public pour la Défense d'avoir accès aux transcrits d'audiences publiques en temps réel par le biais du LiveNote*"¹ filed by the Defence for Mathieu Ngudjolo Chui on 1 April 2008;

NOTING the "Decision Concerning Observations on the Defence Request regarding Real Time Transcripts of Public Hearings"² issued by the Single Judge on 3 April 2008;

NOTING the "*Demande en vue d'obtenir la reclassification d'un document*"³ filed by the Registry on 4 April 2008, in which the Registry requested the Single Judge to reclassify a document on the basis that personal data was contained therein;

NOTING rules 13 and 15 of the *Rules of Procedure and Evidence* ("the Rules"), regulations 8(c) and 26 of the *Regulations of the Court* (the Regulations") and regulations 14 of the *Regulations of the Registry* ("the RoR");

CONSIDERING that document ICC-01/04-01/07-353-Anx1, which is presently classified as a public document, contains the names and email addresses of certain staff members of the Court and internal communication between them; and that there is a need to reclassify the document as confidential;

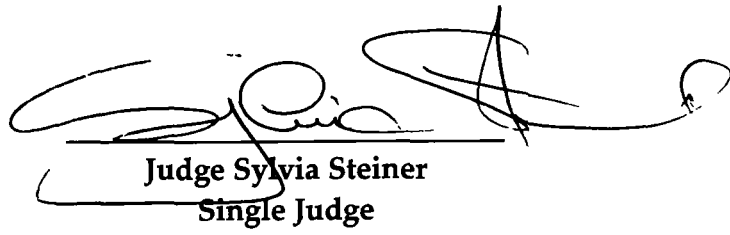
