In compliance with the Single Judge's Order contained in the "Sixth Decision on the Prosecution Request for Authorisation to Redact the Interview Transcripts of Witness 238",¹ the Office of the Prosecutor ("Prosecution") respectfully submits the revised redacted English and French Versions of the Prosecution's Application for Warrants of Arrest against Germain KATANGA and Mathieu NGUDJOLO CHUI originally filed on 22 June and 25 June 2007.² The revised redactions have been implemented taking into account the findings of the Single Judge in the First to Sixth Decisions on Redactions.³

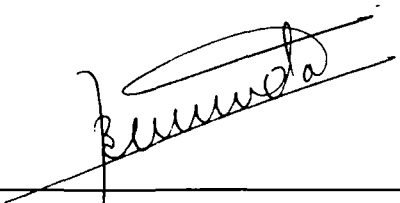
