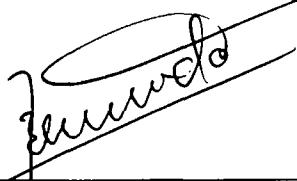

The Office of the Prosecutor ("Prosecution") herewith submits the pre-inspection report for 29 documents provided to the Defence teams of Germain KATANGA and Mathieu NGUDJOLO CHUI on 21 May 2008 pursuant to Rule 77 of the Rules of Procedure and Evidence further to the Single Judge's order of 16 May 2008¹ and in accordance with the terms of the Single Judge's order rendered at the hearing of 22 April 2008.²

Eight of these documents provided to the Defence teams for pre-inspection are those for which Article 54(3)(e) restrictions have been lifted. Additionally, several documents contain redactions as permitted by Part VII of the Single Judge's "Decision on Evidentiary Scope of the Confirmation Hearing, Preventive Relocation and Disclosure under Article 67(2) of the Statute and Rule 77 of the Rules".³
