The Registry of the International Criminal Court (the “Court”),

CONSIDERING that the Chamber granted this request⁴ and order the Registry to file a document containing this EVD number,

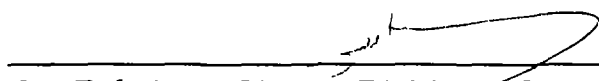

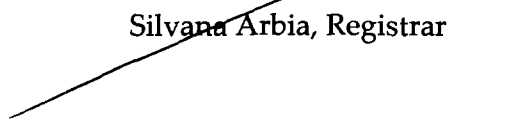
