1. On 20 June 2008 Pre-Trial Chamber III (hereinafter referred to as "PTC") issued an Order¹ requesting the Prosecution to submit a proposal in regards to the classification and requested redactions of the "Prosecutor's Application for Warrant of Arrest under Article 58"² as well as the "Prosecutor's Submission on Further Information and Materials"³ (hereinafter referred to as "Further Submission").

2. On 30 June 2008 the Prosecution submitted the requested proposal⁴, including the English version of the Further Submission with requested redactions (highlighted)⁵ and notified the PTC that it would provide the French translation of the Further Submission, including requested redactions, as soon as possible⁶.

3. In compliance with this notification, the Prosecution respectfully submits as annex A the official French translation of the "Prosecution's Submission on Further Information and Materials" with requested redactions (highlighted).

Request for Sealing

4. The Prosecution requests that this submission and its annex be received by the PTC as "Under seal, Ex Parte, Prosecution Only", since they relate to material that is currently under seal and *ex parte* and depicts information for which redactions are sought. Communication of such information would defeat the purpose for which the redactions are requested.

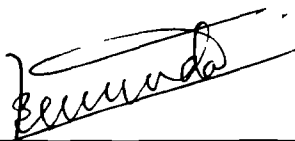
