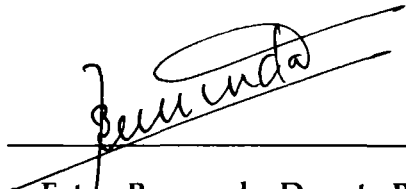

## **I. Introduction**
