NOTING the "*Decision Requesting Observations on the Defence's Application for Interim Release*"³ issued by the Chamber on 4 August 2008;

NOTING "*the Report of the Registrar concerning the Observations Received on the Defence's Application for Interim Release of Mr. Jean-Pierre Bemba Gombo*"⁴ dated 15 August;

NOTING the "*Decision on the application for interim release*"⁵ issued by the Chamber on 20 August 2008;

NOTING the "*Decision concerning the public version of the "Decision on application for interim release" of 20 August 2008*"⁶ issued by the Chamber on 26 August 2008;

NOTING the "*Requête de Mise en liberté Provisoire*"⁷ submitted by the Defence on 3 November 2008;

NOTING the "*Decision requesting Observations on the Defence's Application for Interim release*"⁸ issued by the Chamber on 12 November 2008;

NOTING the "*Second report of the Registrar concerning the Observations Received on the Defence's Application for Interim Release of Mr. Jean-Pierre Bemba Gombo*"⁹ dated 24 November 2008;

NOTING articles 60(2) and 87 of the *Rome Statute* ("the Statute"); rules 118, 119 and 176(2) of the *Rules of Procedure and Evidence* ("the Rules"); regulations 23bis, 24bis and 51 of the *Regulations of the Court* ("the Regulations"); regulation 24(7) of the *Regulations of the Registry*;

CONSIDERING that the Chamber requested the relevant authorities of the Kingdom of Belgium, the Republic of Portugal and the Kingdom of the Netherlands to submit observations by no later than 24 November 2008 on:

- "(i) the application for interim release and
- (ii) the conditions, if any, that would have to be met in order for the State to accept Mr. Jean-Pierre Bemba's release on its territory"¹⁰;

CONSIDERING that the Registry received, on 24 November 2008 after filing hours, the observations of the Kingdom of The Netherlands;

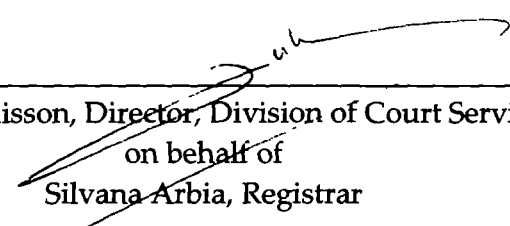
