Trial Chamber II of the International Criminal Court (respectively, “the Chamber” and “the Court”), acting pursuant to article 64 of the Rome Statute, to rule 132(2) of the *Rules of Procedure and Evidence* and to regulation 28 of the *Regulations of the Court*, orders as follows:

1. In its Order of 13 November 2008 the Chamber asked Defence Counsel whether they intended to carry out investigations on the territory of the Democratic Republic of the Congo and, if so, when these would begin and how long they would last.¹ It also asked the Prosecutor and the Defence if they could name the date when they would be ready for commencement of the hearing on the merits.²

2. In his response Counsel for Germain Katanga stated that he planned to conduct investigations in Ituri from 4 to 15 December 2008, in Kinshasa from 15 to 25 January 2009, again in Ituri from 16 to 28 February 2009, in Kinshasa from 23 to 29 March 2009, then in Ituri from 20 April to 3 May 2009. He further stated that the two Defence teams and the Prosecutor had met together and that, if there were no unforeseen difficulties, the trial could open on 8 June 2009.³

4. At the status conference of 3 February 2009, Defence Counsel for Germain Katanga stated that his investigations had been delayed, and that he needed six months to prepare, with effect from the Prosecutor’s final disclosure of incriminatory and exculpatory evidence.

5. In order to be in a position, fully informed, to set a date for the trial and to ensure that the proceedings are conducted in a fair and expeditious manner, the Chamber wishes to be provided as soon as possible with further particulars of the reasons justifying such a time-frame.
