Trial Chamber II of the International Criminal Court (respectively, “the Chamber” and “the Court”), acting pursuant to regulation 35 of the *Regulations of the Court*, orders as follows:

1. On 10 December 2008 the Chamber ordered the Registry to present by 12 January 2009 written submissions enumerating the issues¹ on which it sought guidance from the Chamber, as already summarized by it in its report of 24 November 2008² and at the status conference held on 27 and 28 November 2008.³ The issues in question are the following: (1) witness familiarization; (2) in-court assistance; (3) contact with witnesses of other parties; (4) dual victim/witness status; (5) witness testimony; (6) live broadcast of audiovisual recordings; (7) use of visual aids; (8) Lingala interpretation; (9) schedule of hearings.⁴

2. In its report of 12 January 2009 the Registry addressed the following three issues only: broadcast of audiovisual recordings, use of visual aids, schedule of hearings. At the same time, it requested an extension of the time limit set by the Chamber for the remaining issues, namely: witness familiarization, in-court assistance, contact with witnesses of other parties and dual victim/witness status (“the Request”).⁵

3. The Registry submits that its Request is justified by the “numerous pending deadlines”,⁶ of which it gives particulars in an additional report dated 13 January 2009.⁷ It explains that the Registry department responsible for providing responses

on these issues is currently having to handle, with very short deadlines, a large number of requests from both Trial Chamber I and from the present Chamber. It points out that this particularly heavy workload has come at a time of year when Registry staff numbers are known to be reduced.⁸

4. After considering the reasons put forward by the Registry, the Chamber considers that the Request is properly justified and that it therefore satisfies the requirements set out in regulation 35 of the *Regulations of the Court*.

FOR THESE REASONS, THE CHAMBER

GRANTS the Request;

ORDERS the Registry to submit an additional document on the remaining issues by 4.00 p.m. on 21 January 2009;

ORDERS the Prosecutor, Defence Counsel and the Legal Representatives of the Victims to file their responses on all of the issues, including those already addressed in the report of 12 January 2009, by 4.00 p.m. on 28 January 2009.
