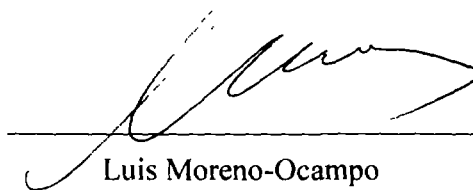

1. On 20 November 2008, the Office of the Prosecutor ("the Prosecution") filed an Application under Article 58 of the Rome Statute, requesting that Pre-Trial Chamber I issue warrants of arrest or, alternatively, summonses to appear for the three individuals named therein ("the Application")¹. The Application was classified "Confidential-Ex parte Prosecution Only".
2. On 9 December 2008, the Chamber issued its "Decision Requesting Additional Information and Supporting Materials"² ("the Decision"), requesting the Prosecution to submit additional information and supporting materials in relation to those aspects of the Application referred to in a confidential *ex parte* Annex thereto.³
3. Pursuant to the Decision, the Prosecution hereby submits, as confidential *ex parte* annexes, the following:
 - (i) Confidential *ex parte* Annex A: Additional information and written answers to the specific questions posed by the Chamber.
 - (ii) Confidential *ex parte* Annex B: Schedule containing the list of Additional Supporting Materials requested by the Chamber.
 - (iii) Confidential *ex parte* Annexes B(1)-(24): Additional Supporting Materials requested by the Chamber and in support of the Prosecutions response contained in Confidential *ex parte* Annex A.
