1. On 20 November 2008 the Office of the Prosecutor (“the Prosecution”) filed an Application pursuant to Article 58 of the Rome Statute (“the Application”) requesting Pre-Trial Chamber I (“the Chamber”) to issue summonses to appear for Bahar Idriss **Abu Garda** and two others.¹
2. On 7 May 2009, the Chamber issued a summons for Bahar Idriss **Abu Garda** to appear before the Court.²
3. On 18 May 2009 during the initial appearance, the Single Judge scheduled the Confirmation Hearing for 12 October 2009.³ The date of the hearing was subsequently postponed to 19 October 2009.⁴
4. On 10 September 2009, pursuant to Article 61(3) of the Statute of the Court and rule 121(3) of the Rules of Procedure and Evidence, the Prosecution filed with the Registry the Confidential Version of the Document Containing the Charges⁵ and the List of Evidence⁶.
5. The Prosecution submits in Annexes A and B the Public Redacted Version of the Document Containing the Charges and the List of Evidence, respectively.
