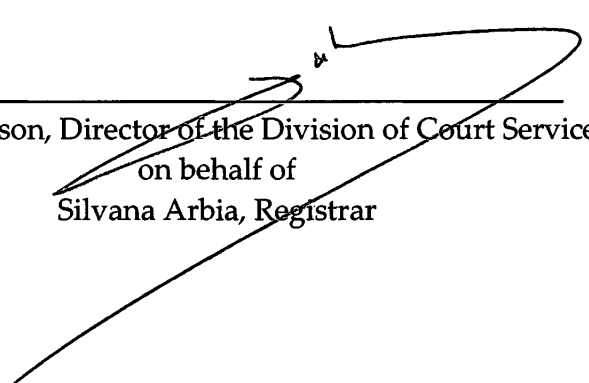
CONSIDERING that in its Application the Defence sought the admission into evidence of fifteen documents used during its questioning;
