1. The Office of the Prosecutor (“Prosecution”) submits in appended Annex A the Updated In-Depth Analysis Chart of Incriminatory Evidence (“Updated Analysis Chart”). This chart is submitted in response to the “Decision on the Prosecution’s Submission on the Trial Chamber’s 8 December 2009 Oral Order Requesting Updating of the In-Depth-Analysis Chart” issued by the Trial Chamber III (the “Chamber”) on 29 January 2010.¹
2. The Prosecution requests that Annex A be received as “Confidential, *Ex Parte*, Prosecution and Defence Only” as it contains confidential information pertaining to witnesses known to the Defence but not to the Public.
3. The Updated Analysis Chart consolidates the charts previously submitted by the Prosecution, namely on 24 November 2008² and 30 March 2009.³ It follows the structure of the previous versions and relates the factual allegations to the pertinent legal elements. It analyses the evidence disclosed since the pre-confirmation hearing disclosure, including witness statements.
