The Office of the Prosecutor ("Prosecution") submits the pre-inspection report regarding the disclosure to the Defence teams of Germain Katanga and Mathieu Ngudjolo Chui of seventeen documents pursuant to Rule 77 of the Rules of Procedure and Evidence, on 8 March 2010.

Thirteen of the documents relate to witnesses 33, 37, 47, 52, 68, 90, 113, 169, 175, 178/253, 243, 282 and 288 and were disclosed pursuant to Trial Chamber II's ("the Chamber") decision of 25 February 2010.¹ The disclosure also included three interview transcripts of witness P-157 and one investigator's note related to witness P-159, disclosed pursuant to the Chamber's oral decision rendered during a hearing held on 22 February 2010.²
