1. In compliance with the order of Trial Chamber III ("the Chamber") at the status conference held on 8 March 2010,¹ the Office of the Prosecutor ("Prosecution") herewith notifies the Chamber that it released to the Office of Public Counsel for Victims ("OPCV") and the Legal Representative of Victims² materials relevant to Defence's "Requête en vue de contester la recevabilité de l'Affaire conformément aux Articles 17 et 19 (2) (a) du Statut de Rome"³.

Following the Chamber's instructions, the Prosecution has applied redactions to the names, identities and references to individuals that could put them at risk following disclosure to the OPCV and the Legal Representative.
