NOTING the Registrar's decision of 5 January 2010 rejecting the permission sought by Aprodec asbl President to visit the detained persons (the "Impugned Decision")¹ and the reasons of such refusal;²

NOTING the Presidency "Decision on the admissibility of Aprodec's "Requête en Annulation de la Décision du Refus de Visite opposé par le Greffier le 5 janvier 2010. Et, Contestation du Comportement et l'Aptitude du Greffier à exercer les Fonction prévues à l'Article 43(1)" dated 23 March 2010;³

NOTING Regulations 24 *bis*, 90 and 100 of the Regulations of the Court, and Regulation 180(3) and 187 of the Regulations of the Registry;

CONSIDERING that the Presidency in its decision of 23 March 2010 ordered *inter alia* the Registrar to notify the detainees of the Impugned Decision if she has not done so yet;

INFORMS the Presidency that the detainees were informed of the Registrar's decision by the Chief Custody Officer, acting on behalf of the Registry, by way of a notification dated 14 January 2010⁴ providing the reasons referred to in the Impugned Decision;

INFORMS that in addition to the notification of 14 January 2010 and because the Presidency explicitly referred to the annexes 6 and 8 of the application of Aprodec asbl in its decision, those annexes will be provided to the detainees today;

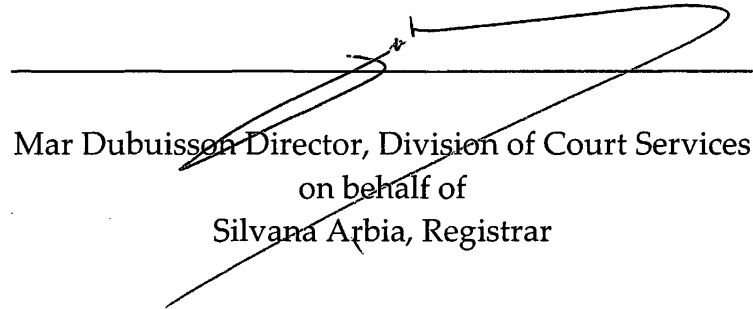
