1. The Office of the Prosecutor ("Prosecution") submits in appended Annex A the Second Updated In-Depth Analysis Chart of Incriminatory Evidence ("Second Updated Analysis Chart"). This chart is submitted in compliance with the "Decision on the prosecution's second application for disclosure of additional evidence" ("Decision") issued by Trial Chamber III ("Chamber") on 5 May 2010.¹ This Second Updated Analysis Chart contains additional evidence of three Prosecution's witnesses, the disclosure of which was granted under the conditions set forth in the Decision.

2. The Prosecution requests that Annex A be received by the Chamber as "Confidential, *Ex Parte*, Prosecution and Defence Only" as it contains confidential information pertaining to witnesses known to the Defence but not to the public.

3. The Second Updated Analysis Chart consolidates the charts previously submitted by the Prosecution on 24 November 2008,² on 30 March 2009,³ and on 1 March 2010.⁴ It maintains the structure of the previous versions and relates the factual allegations to the pertinent legal elements. The additional evidence has been included at the end of the factual allegations under each legal element respectively.
