Trial Chamber III (“Chamber”) of the International Criminal Court (“Court”), in the case of *The Prosecutor v. Jean Pierre Bemba*, issues the following Order inviting the parties’ observations on 192 victims’ applications for participation.

1. On 14 June 2010 the Registrar filed *ex parte* (only available to the Registry), its “Second report to Trial Chamber III on applications to participate in the proceedings”, along with the applications of 192 individuals wishing to participate in the current proceedings.<sup>1</sup>
2. On 15 July 2010, pursuant to an order of the Chamber, the Registry transmitted redacted versions of the 192 applications to the parties.<sup>2</sup>
3. Pursuant to Rule 89(1) of the Rules of Procedure and Evidence and Regulations 34 and 35 of the Regulations of the Court, the Chamber orders the parties to file responses on the 192 applications by 16.00 hours on 20 August 2010.
4. As set out in the Decision on the participation of victims in the trial and on 86 applications by victims to participate in the proceedings, the legal representatives will need to seek the permission of the Chamber in accordance with Regulation 24 of the Regulations of the Court if they wish to file a reply to the parties’ observations.<sup>3</sup>

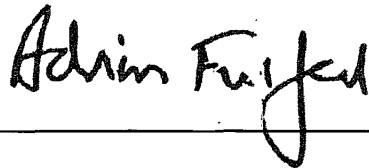
