The Office of the Prosecutor ("Prosecution") herewith notifies Trial Chamber II of its disclosure, on 25 August 2010, to the Defence teams of Germain Katanga and Mathieu Ngudjolo Chui, of 4 video excerpts and 6 documents as incriminatory evidence.

The video excerpts re-disclosed in INCRIM Package 66 are from video DRC-OTP-1017-1482 related to P-2. These excerpts¹ were disclosed on 20 August 2010² and were re-disclosed on 25 August 2010 with minor adjustments due to a technical inaccuracy.

The documents in INCRIM Package 67 are transcripts related to P-353. These transcripts were re-disclosed in fully unredacted form, in accordance with Trial Chamber II's Decision ICC-01/04-01/07-1178-Conf-Exp and pursuant to a request of the defence team of Germain Katanga received by way of e-mail on 23 August 2010.³
