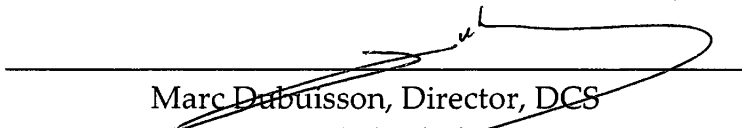
THE REGISTRAR of the International Criminal Court;
