The Registrar of the International Criminal Court (the “Court”);

NOTING Trial Chamber III’s “Decision on common legal representation of victims for the purpose of the trial” dated 10 November 2010 (the “Decision on common legal representation”),¹ authorizing the Registry to designate two common legal representatives from the Central African Republic to represent the totality of the victims allowed to participate in the present case;

NOTING the Registrar’s “Corrigendum to Notification of designation of common legal representatives”² designating Mr Assingambi Zarambaud and Ms Marie Edith Douzima Lawson as legal representatives for all victims participating in the present case;

NOTING Trial Chamber III’s “Decision on 772 applications by victims to participate in the proceedings”³ (the “Decision”) granting participating status to 624 applicants;

NOTING article 68(1) of the Rome Statute; rules 90(2) to 90(5) of the Rules of Procedure and Evidence, and article 16 of the Code of Professional Conduct for Counsel;

CONSIDERING that no conflict of interests has so far arisen in the representation of victims allowed to participate in the present case, that article 16 of the Code of Professional Conduct for Counsel obliges legal representatives to ensure that no such conflict arises and, in case of difficulties or objections raised by a victim during the period of transition, to communicate such issue to the Registry and the Chamber so that appropriate measures are taken;

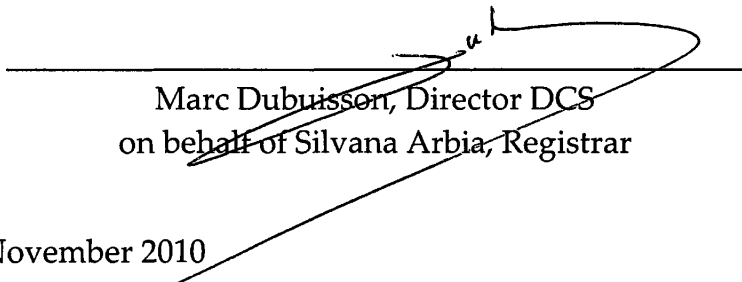
INVITES both legal representatives to inform the Registry and the Chamber subsequently should any conflict of interests occur in the future;
