Introduction

1. The purpose of this filing is to notify the Chamber on the possibility of travel by President Omar Al Bashir to the Republic of Senegal and to the Republic of Zambia in December 2010.

Procedural Background

2. On 14 July 2008, the Prosecution filed its application for an arrest warrant for Omar Al Bashir.¹
3. On 4 March 2009, the Chamber issued an arrest warrant for Omar Al Bashir for seven counts of crimes against humanity and war crimes. In the decision, the Chamber found that “under Article 58(1) of the Statute, the arrest of Omar Al Bashir appears necessary at this stage to ensure (i) that he will appear before the Court; (ii) that he will not obstruct or endanger the ongoing investigation into the crimes for which he is allegedly responsible under the Statute; and (iii) that he will not continue with the commission of the above-mentioned crimes.”²
4. On 5 and 6 March 2009, the Registry submitted 3 filings to the Chamber, detailing transmission of the warrant of arrest and the requests for its implementation to the Government of the Sudan³, to all Rome Statute States Parties⁴ and to the members of the UN Security Council.⁵

5. On 12 July 2010, the Chamber issued a second arrest warrant for Omar Al Bashir for three counts of genocide.
6. The Registry submitted additional filings on 15 September 2010, on the transmission of the requests and supplementary requests for the arrest and surrender of Omar Hassan Ahmad Al Bashir to States Parties, Non-States Parties Members of the United Nations Security Council and the Republic of the Sudan.

Reports of Omar Al Bashir's possible travel to the Republic of Senegal and the Republic of Zambia

7. Public statements and publications have suggested that Omar Al Bashir intends to visit the Republic of Senegal in the period between 10 – 31 December 2010 and the Republic of Zambia on 15 December 2010. For example, news reports published on the Sudanese official news agency (SUNA) website indicate that Omar Al Bashir might attend the 3rd World Festival of Negro Art which will take place from 10 - 31 December 2010 in Dakar, Senegal.⁶⁷⁸ On 6 December 2010, SUNA reported that Omar Al Bashir had received an invitation from his Zambian counterpart, Rupiah Banda, to participate in the Special Summit of the International Conference on the Great Lakes Region (ICGR), which is scheduled to take place in the capital, Lusaka, on 15 December 2010.⁹
8. Furthermore, the Prosecution understands that some States Parties are working bilaterally and within the framework of regional organizations to try to discourage the visits, and civil society organizations are endeavouring to ensure

that the warrant will be executed, should Omar Al Bashir visit the Republic of Senegal and to the Republic of Zambia.

Relief Sought

9. The Prosecution believes, in line with earlier submissions to the Chamber that this information may be of interest to the Chamber. The Prosecution will submit any additional confirmation it receives of Omar Al Bashir's planned visits to the Republic of Senegal and the Republic of Zambia.
