Introduction

1. The Office of the Prosecutor ("Prosecution") herewith submits the pre-inspection report regarding six documents disclosed to the Defence team of Mr. Jean-Pierre Bemba Gombo ("Defence") on 31 January 2011 pursuant to Rule 77 of the Rules of Procedure and Evidence.
